# **DELEGATION OF ETHIOPIA VISITING SEW**

Mozambique customs have collected more than 68 million meticals ever since the roll-out of the Single Electronic Window (SeW), three year ago, and period during which a total of 677.319 declarations have been lodged to customs.

These data were made public by Félix Massangaie, Director of Regimes, Custom Tariff Schedule and Manager of the Single Electronic Windows, that makes a positive assessment about the deployment of this electronic system for faster clearance of goods, that is also the first public online service.

"During this period, we deployed and rolled out all modules that are directly involved in the collection of taxes and other charges and this has a positive impact on the State and to the private sector, because it reduced significantly the times to clear to goods, apart from having

contributed to the reduction of the costs of its implementation in the ports, airports and bonded warehouses" and other facilitation mechanisms are being continually implemented in the user of the SeW tool, explained Félix Massangaie.

According to Félix Massangaie, the reduction of times and cost to clear goods has contributed to the improvement of the business environment in the country and has enable customs authority to have more control.

In another development, the Director of Regime, custom schedule, Valuation and Manager of the Single Electronic Window, has made public that from January to the present moment, more than 320 thou-

sand declarations were processed, and this proves a that a lot of foreign trade operators joined the SeW.

"In terms of declarations issued in the SeW by year, we went from 44 in the first year of the implementation of the system (2011) to more than 321 000 in 2014. Simultaneously, with the use of the SeW we have noticed improvements in the customs clearance processing as well as the reduction in the times to clear goods through customs, he added.

Félix Massangaie made this information public during a visit of a Delegation of Ethiopian Revenue Authority to the Operation Center of the Single Electronic Window, completed this Thursday, December 11th.

The visit, according to Abreham Nigussie, deputy Director of the Ethiopian Revenues and Customs Authority and head of the delegation, had as the objective to collect the Mozambican experience in the design and Management of the Single Electronic Window, that is seen as an example at the level of the African Continent.

"Ethiopia is preparing to make changes to the tax and customs administration system, that will also entail deploying a Single Electronic Window solution. We know that Mozambique has an extensive experience in this area and we are here to learn", said Abreham Nigussie.

It should be noted that delegations from various African Countries have already visited Mozambique to become familiar with the implementation of the Single Electronic Window System.

### Did you know that:

(A)

The system now allows assistants of clearing agents to create applications for exemption?

Yes, with an aim to facilitate the activities of the clearing agents established as companies, a role with rights to create Global lists/Applications for exemptions for the assistants was created, however, only clearing agents should submit the application.

(B)

And that, the system now allows the submission of exemption based on the global list created by another clearing agent?

In case the operator of foreign trade decides to appoints a different clearing agent from the former, the new clearing agent only has to select the global list previously selected for the submission of the exemption requests.
